

## Ten Year Limited Written Warranty Light Transmission and Yellowness and Five Year Limited Written Warranty Hail Damage

Standard LEXAN™ Corrugated sheet grades will not break due to loss of impact strength through weathering within five (5) years of the date of sale by SABIC's Innovative Plastics business and will not display excessive yellowing and loss of light transmission within ten (10) years of the date of sale by SABIC.

### This limited written warranty is subject to the following conditions:

- 1) This limited written warranty applies solely to standard LEXAN Corrugated sheets produced by SABIC's Innovative Plastics business in Long Sault, Canada, in the colors standard clear (112), opal white (82338) and bronze (512022), used correctly as flat, sloped or curved glazing, handled, stored, processed, installed and maintained according to SABIC's Innovative Plastics business' recommendations. In all cases, the surface bearing the proprietary UV protection must be the only side exposed to direct sunlight and the effects of weather.
- 2) This limited written warranty does not apply to sheet that has been thermoformed, scratched, abraded or exposed to corrosive materials or chemicals.
- 3) This limited written warranty is given only to the original purchaser of SABIC's sheet and does not extend to any subsequent purchaser or transferee. Any warranty claim hereunder must be made immediately within the warranty period by specifying the claim in writing and submitting to SABIC the original sales receipt which must contain the name and address of the purchaser, the date of purchase, the complete product name, the lot number and the volume purchased. On request of SABIC claimant must allow the material to be inspected on site and/or return the sheet to SABIC's Innovative Plastics business for testing.
- 4) For the purpose of this limited written warranty:
  - Penetration by Hail: This product shall be warranted against hail breakage (defined as surface penetration that permits water to leak through the sheet) from hailstones up to 7/8' (22.2mm) traveling at speeds up to 100 ft/sec (30 m/sec). Resolution of claims will be determined through subsequent impact testing on a undamaged sample of the sheet in question using the ASTM 3029/Ford Modified Gardner test. Any sheet which sustains surface penetration at less than 5 ft-lbs when tested shall entitle the purchaser thereof to replacement of sheet in accordance to schedule under item 6. The warranty does not cover impact failures or breakage caused by other means, intentional or unintentional.
  - Yellowing will be determined by subjecting a cleaned sheet sample to the Yellowness Index Test ASTM D1925. Any claims for sheets displaying a change in Yellowness Index of 10 units or less for standard clear (112) compared with their original value, will not be accepted.
  - Loss of light transmission will be determined by subjecting a cleaned sheet sample to the Light Transmission Test ASTM D1003 (1977). Any claims for sheets displaying a loss of light transmission of 10 % or less, compared to the original value, will not be accepted.
- 5) SABIC's Innovative Plastics business reserves the right to investigate independently the cause of any failure.
- 6) If a claim under this limited written warranty is justified, SABIC will provide the purchaser with replacement material free of charge in accordance with the following schedule:

If replacement material cannot be provided within a reasonable period of time, SABIC may opt to refund the original purchase price paid to SABIC's Innovative Plastics business, or a portion thereof, in accordance with the above schedule.
- 7) This limited written warranty shall be SABIC's sole liability and customer's exclusive remedy for the products and all other claims for damages are excluded. The limited written warranty is in lieu of all other warranties (except of title), written or oral, statutory, express or implied, including any warranty of merchantability or fitness of purpose. This limited written warranty shall be governed by the laws of the Netherlands.
- 8) This limited written warranty has been issued on September 10<sup>th</sup>, 2013, is restricted to material sold by SABIC's Innovative Plastics business after such date and supersedes all previously issued warranties for the products mentioned above.

This limited written warranty has been issued on March 17th 2008.

This is the sole warranty for Lexan Corrugated sheet, sold after said date.
