

# WARRANTY CONDITIONS

## LEXAPANEL™ STANDING SEAM SHEET

### TEN (10) YEARS LIMITED WRITTEN WARRANTY

LEXAPANEL™ Standing Seam sheet will not break due to loss of impact strength through weathering and will not display excessive yellowing and loss of light transmission as defined herein, within ten (10) years of date of sale by SABIC.

This limited written warranty is subject to the following conditions:

1. This limited written warranty applies solely to LEXAPANEL sheets produced by SABIC in the colors standard clear (112), opal white (WH7A092X) and standard bronze (515055), used correctly as sloped, vertical or cold curved glazing, handled, stored, processed, installed and maintained according to SABIC's recommendations contained in the Technical Manual. In all cases, the surface bearing the proprietary UV protection must be the only side exposed to direct sunlight and the effects of weather.
2. This limited written warranty does not apply to sheet that has been thermoformed, scratched, abraded or exposed to corrosive materials or chemicals.
3. This limited written warranty is given only to the original purchaser of SABIC sheet and does not extend to any subsequent purchaser or transferee. Any warranty claim hereunder must be made immediately within the warranty period by specifying the claim in writing and submitting to SABIC the original sales receipt, which must contain the name and address of the purchaser, the date of purchase, the complete product name, the lot number and the volume purchased. On request of SABIC claimant must allow the material to be inspected on site and/or return the sheet to SABIC for testing.
4. For the purpose of this limited written warranty:
  - a. Loss of impact strength through weathering leading to hail breakage will be determined by subjecting an undamaged sample of the sheet to a standard hail simulation test developed by KRI-TNO, Delft, The Netherlands. Acceptance of a claim under this limited written warranty requires that this test (10 shots with artificial hailstones of 20mm in diameter aimed at different points of the sheet surface with a speed of 21 m/s causes at least 5 holes in the weathered surface of the sheet).
  - b. Yellowing will be determined by subjecting a cleaned sheet sample to the Yellowness Index Test ASTM D1925 (1977). Any claims for sheets displaying a change in Yellowness Index of 10 units or less compared with their original value, will not be accepted.
  - c. Loss of light transmission will be determined by subjecting a cleaned sheet sample to the Light Transmission Test ASTM D1003: 2011. Any claims for sheets displaying a loss of light transmission of 2% or less, for standard clear (112) and opal white (WH7A092X) compared to the original value, will not be accepted.
  - d. SABIC reserves the right to investigate independently the cause of any failure.

5. If a claim under this limited written warranty is justified, SABIC will provide the purchaser with replacement material free of charge in accordance with the following schedule:

Time from Orig. Purchase Date	Material Replacement
<b>Up to 5 years</b>	100%
<b>in 6th year</b>	75%
<b>in 7th year</b>	60%
<b>in 8th year</b>	45%
<b>in 9th year</b>	30%
<b>in 10th year</b>	15%

If replacement material cannot be provided within a reasonable period of time, SABIC may opt to refund the original purchase price paid to SABIC, or a portion thereof, in accordance with the above schedule.

6. This limited written warranty shall be SABIC's sole liability and customer's exclusive remedy for the products and all other claims for damages are excluded. The limited written warranty is in lieu of all other warranties (except of title), written or oral, statutory, express or implied, including any warranty of merchantability or fitness of purpose. This limited written warranty shall be governed by the laws of the Netherlands.
7. This limited written warranty has been issued on August 12, 2012, is restricted to material produced by SABIC after such date and supersedes all previously issued warranties for the products mentioned above.
